#### MELANIE JEFFREY - Norbury Theatre, Droitwich

I have been involved in amateur theatre for as long as I can remember but only for the past 14 years in the West Midlands. I am one of the Directors of the Norbury Theatre in Droitwich and I am responsible for some of the Marketing there. I am usually involved in a lot of the productions either acting or as director. I directed the NODA award winning production of Journey's End in 2018 and last year directed Annie. I am now in the process of being in Charley's Aunt as well as directing our summer musical Legally Blonde.

#### **DEBBIE HIBBERD - Rugby Theatre, Rugby**

I have been a member of Rugby Theatre since 1983, finally taking life membership in 2005. I act whenever there is a part to audition for, for a lady of my age! In the last year I was the fool in King Lear and a nun in the Sound of Music.

I started our Theatre Writers group. I am completing the Directors course, with a view to directing in the future. I've also done the scenic designer course but did that mainly to learn more about our stage and how it works together with sound and lighting, from a writer's viewpoint. I've been the Props Group leader, but still work full time in education, so I am only a props team member at the moment.

I work regularly in our box office, our theatre bar and do a stint on Front of House for live shows. I'm a trained film manager for film showings. I am a trained chaperone and do this mainly in our summer youth theatre project. I have a toe in lots of different aspects of theatre life!

I am on my second '3-year term' as a 'member voted' trustee and currently I am the Chair of the Trustee Board. I collate a weekly members newsletter, with interviews, photos and information, so members know what's going on (only if they read it of course!)

I feel I would have something useful to contribute to the LTG national committee and put myself forward to stand for this, this year.

#### VICE CHAIR - NICK MORLEY - Sinodun Players, Wallingford

Nick moved to Wallingford in 1993 and almost straight away joined the Sinodun Players. Whilst mainly carrying out nearly any technical role, he did act in 'Absolute Hell' in the late 90s.

He was Technical Manager for a few years before joining the Board of Sinodun Players Ltd in 2004. In 2006 he became Chair of the Board and was heavily involved in the Foyer Refurbishment project in 2007. In 2008 Nick left the Board to concentrate on other areas, including running both the Bar and Cinema rotas.

In 2013 Nick joined the Trustees and became Chair a year later, at a difficult time for the Sinodun Players. He stepped up the Sinodun Players relationship with LTG and started encouraging attendance at conferences

Alongside the Financial Trustee he worked on changing our Constitution and renaming our trading subsidiary. These changes were necessary to be able to attract large grants for our Roof Project, carried out in 2017. Nick stood down as Chair in 2019 but remains heavily involved, including being the Designated Premises Supervisor.

Nick was an MOD Civil Servant for 21 Years, the last 12 being in the IT Project Management Function. For the last 5 years he has been an IT Contractor working in Software Asset Management.

In other spare time he is an Oxfam Festival Steward in the summer and an Assistant Shift Leader for Crisis Christmas.

Nick never joined any organisation to be on Committees yet always seems to end up on them quite willingly. I am quite happy to put myself forward to be LTG Vice Chair and help the organisation continue to move forward.
