1. Nick Morley opened the 79th LTG AGM at 14:53 at Royalty Theatre, Sunderland. At the request of Nick Morley, delegates remembered with a round of applause those who had died during the year, especially Tom Williams, Chesil Theatre, Patricia Clough, Bingley Little Theatre and Margaret Whitehouse, Hall Green Theatre. All had been longstanding members of LTG and all are Honorary Associates of the LTG.

Anne noted that **34 LTG Members** had not responded either with an acceptance or apologies to her emails about the LTG National Conference.

Announcement of proxy holders – there were none although some LTG Reps had delegated the voting role to another member of their theatre who was attending the conference.

- 2. Approval of the Minutes of the 78th AGM held at Sutton Arts Theatre 22-23 June 2024. The minutes were proposed by Caroline Chapman and seconded by Debbie Hibberd and approved.
- a. **Matters arising from the Minutes** there were none.
- b. **Chairman's Report** Nick noted that his report was on the webpage which he hoped delegates had read and there were two issues he wanted to comment on. First the **LTG Yearbook.** He noted that Anne had to send out a number of reminder emails and he asked delegates to ensure that their theatre responded to Anne's emails even if the response was 'we have not yet got the figures'. This ensures Anne knows you have received the email. Second, with the unanimous vote of the National Committee, I can announce we have a new Hon Associate. An Hon Associate is someone who has done sterling work for the LTG and I would like to announce that Mike Smith has been made the latest Hon Associate. (Applause).
- **3. Treasurer's Report** Brian noted that the Accounts were on page five of the LTG Yearbook 2024-2025 and showed a surplus of £7,300 and total assets of £55,666. He noted that individual headings are broadly in line with expectations. Expenditure was a little higher due to more travelling by the National Committee and the increase in the level of capped expenditure to encourage those on the committee to attend meetings. The other increase was mainly due to holding the Intimacy workshop and a small increase in the cost of publishing the LTG Yearbook.
- a. Brian noted that the membership income continued to grow but the surplus in the current year will not be as great as this year. Brian thanked those who pay promptly but there are still a few LTG Members who still have not paid despite regular reminders.
- b. Brian noted that these figures had been reported to the Charity Commission. Brian offered his thanks to Sandra McGuire for efficiently auditing the accounts and to the National Committee to for their care over expenditure. There were no questions.
- **4. Approval of Accounts as printed in the LTG Yearbook 2023-2024** Brian proposed that the accounts were accepted. They were agreed and seconded by **Eddie Redfern** and unanimously approved.
- **5. Election of Officers** –Nick asked that holders of the roles confirm they were content to be elected for another year. These were Hon Sec, Anne Gilmour, confirmed; Treasurer, Brian Stoner, confirmed; NLO, Mike Smith, confirmed.
- a. He noted that Aleyn Lester had come forward to fill the PRO role formerly held by Kevin Spence. Sarah Clarke was standing down as the Central Region RCM and Suzanne Swan from

Rugby Theatre had agreed to stand for the role. Delegates confirmed they were content to agree all these appointments *en bloc* and they were passed unanimously.
